Data skills are deepened through topics in the field of business intelligence. Here, data is processed, visualised and interpreted using business intelligence tools. Contents	Students will develop a foundational understanding of the essential terms, technologies, and components of IT and OT security within digitalized production environments. This encompasses a thorough comprehension of the threat landscape necessary for evaluating a company's risk profile. Furthermore, students will gain comprehensive knowledge of both technical and organizational measures. On a technical front, these measures encompass adherence to fundamental principles of network security as per ISO 62443 standards. Practical implementation of security measures mandated by the standard will be executed using the BSI basic protection framework. Standard network analysis tools will be employed, alongside network segmentation and secure configuration of switches and firewalls. Backup strategies and patch management are discussed. On an organizational level, students will be introduced to Information Security Management Systems (ISMS) along with threat and risk analysis methodologies. They will learn to enact policies through rights and role management and become acquainted with tools for identifying network anomalies such as Security Information and Event Management (SIEM) systems and Intrusion Detection Systems (IDS). Hands-on exercises will reinforce the practical aspects of the curriculum.
